If photocopies are submitted, investors must produce original for verification. 5. Bank account change details request will be accepted and processed only if all the details are correctly filled and the necessary documents are submitted. The request is liable to be rejected if any information is missing or incorrectly filled or if there is deficiency in the documents submitted. 6. Resident individuals can either select bank account type as SB (Saving Account) or CA (Current Account). 7. Non Resident Individuals need to mandatorily provide NRO or NRE Bank account details. 8. IFSC & MICR code are important for dividend / redemption credits into your account through NEFT or ECS mode.
